### **THE MAJOR CAUSES FOR A CHILD BECOMING DESTITUTE**

1. Broken families
2. AIDS Victim parents
3. Extremely poor and helpless single parent or both parents
4. Parent(s) died of illness other than AIDS
5. Insurgency problems
6. Parent(s) died either in an accident or committed suicide
7. Abandoned by parents.

Children constitute the most vulnerable section of society and are considered a supremely important asset of our nation. Safeguarding the rights of our children is the primary responsibility of each and every individual member of the society. Besides the co-ordination and co-operation amongst the different Child Line Departments of the state and Central Government, the responsibility need not be fixed to only one category, community or group. It is therefore, incumbent on us to work towards ensuring security to children during their childhood days. Any child who is not getting proper care even if his/her parents are alive, e.g. father is a criminal and is in jail and mother is not well so there is no one to take care of the child, so the child will be called as destitute child. Quite a substantial portion of our population is economically deprived and socially incapacitated. Therefore, children are always in need of protection within the conditions under which they live.

The core program of Surabi is Brindavan -- a home for homeless children. According to government data nearly two to three million (20-30 lakhs) children between the ages of 5-14 in Tamil Nadu are deprived of educational opportunities and forced to work for their own upkeep or to support their families. A large number of these children work in the service sector in cities and towns, mainly employed as domestic servants or as laborers in tea stalls, hotels, automobile workshops, petrol pumps, rag picking, etc. Many of these children live on the streets, bereft of family support and exposed to sexual exploitation and hazardous conditions. Surabi is shouldering some responsibility in alleviating these hazards by providing housing at Brindavan and by providing them food, education, sporting activities and nurturing and helping them become responsible citizens.

Brindavan is now operating out of a rented place, where we have space constraint and other operational difficulties. Surabi has official permission to accommodate only 12 children within the available space. With a view to expand our capacity and help more children, Surabi has taken on the major task of constructing its own building to house Brindavan.

Government have prescribed guidelines for the functioning of child care institutions, however at certain times, surabi is unable to justify the reasons raised by government officials especially in amenities like play ground, separate sick room, caretakers accommodation, dining room, vocational training room etc, as we have much space constraint for all the mandatory requirements.

Brindavan not only offers children education but opportunities to learn and develop skills in sports, arts and music and academic competitions. At present, Surabi has 12 deserving children in its care in the Brindavan program.

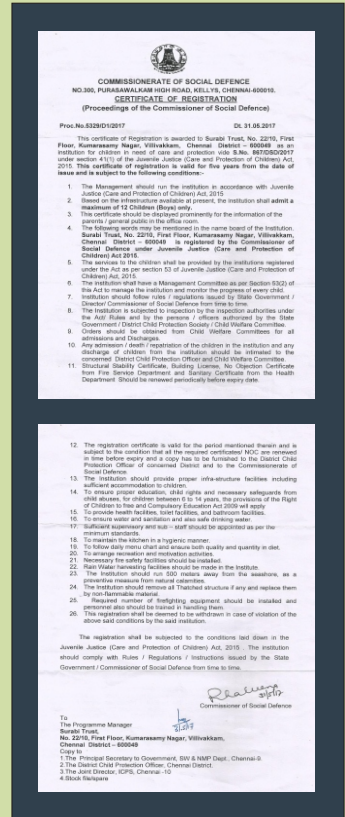
In the past Nine years since its inception the Brindavan program has helped 70 children, including a seventh grade school dropout who is now working as an engineer after completing diploma in electrical engineering. A few other children are in high school and about to graduate and go on to college.

### **OUR MISSION**

Mainstreaming the Orphan, Semi Orphan and Street children in the national building by providing care, support & protection through shelter, food and education is our mission.

### **PROJECT - OVERVIEW**

The issue of an orphan, semi-orphan and street children is not properly addressed. In our project area many Orphan, Semi Orphan and Street Children are found. The problem of orphan/street children is acute due to urbanization and industrialization. Due to the Deaths of HIV/AIDS affected persons, Re-marriage of Deserted / Widowed / Divorce women, Absence of love and security in the families, Family disputes, Unwanted pregnancy of Trafficking / Sexually exploited girls, these orphan and street children are left without care and support. These children are involved in rag picking, pickpocketing and participating in anti-social, criminal activities. Therefore, we envisage main streaming these children in the national building by providing care, support and protection in our ORPHAN CHILDREN HOME. The project proposed in this scheme is meant for additional support to run the orphan children home.

### **PROJECT - OBJECTIVES**

To provide orphan / semi-orphan / street children, a childhood that they never experienced and help them to become useful members of society.

To encourage orphan / semi-orphan / street children to kindle their potential by providing creative opportunities.

To make available a secure place where orphan / semi-orphan / street children can play and enjoy their childhood.

To provide basic education to orphan / semi-orphan / street children.

To provide such welfare services like free lodging, boarding, health and recreation.

To provide basic literacy and facilities for those who wish to study further.

To select and prepare for a vocation in order to live on their own legs.

To accomplishing physical, intellectual and aesthetic development of the child.



### **PROJECT - METHODOLOGY**

We have been identifying orphan / semi-orphan / street children through our volunteers, citizens, police, women & child welfare department. Preview of the incoming orphan / semi-orphan / street child problems/difficulties. We counsel and arrange for Emotional acceptance of the orphan / semi-orphan / street child. We provide Lodging and boarding facilities for all inmates. We arranged to teach facilities in nearby schools according to their age. We also provide home tuitions, recreation and health care.

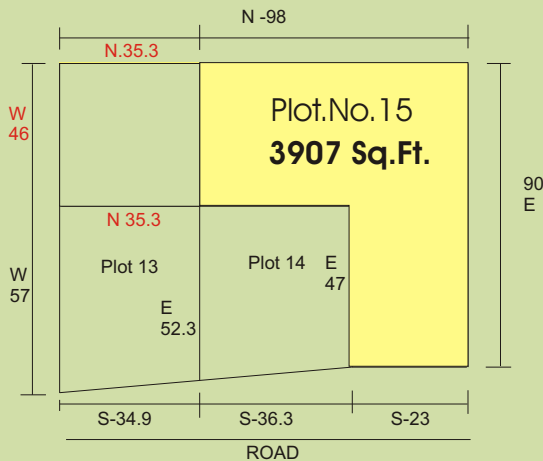

### **PROJECT -IMPACT ANALYSIS**

The project will be monitored at regular intervals through a "Project Advisory Committee (PAC)" constituted with the President of the organization as convener/member secretary.
